Dear Secretaries Pompeo, Azar, McAleenan, and Esper:

As the administration prepares to set the Presidential Determination (PD) on refugee admissions for fiscal year 2020, the undersigned 172 organizations urge the United States to continue to be a beacon of hope and freedom for all people fleeing displacement and persecution by setting a minimum PD of 95,000. We are dismayed by recent reports that the PD may be set to zero, or again significantly lowered, for fiscal year 2020. Such a decision would mean turning our backs on nearly 40,000 refugees who have already been vetted by the U.S. government and approved for resettlement, and continuing to dismantle decades of commitment to the U.S. resettlement program.

Since the U.S. Refugee Admissions Program (USRAP) was formally established in 1980, the U.S. has proudly resettled over three million refugees. Welcoming refugees has enhanced our local

economies and communities, strengthened our foreign policy, and bolstered our standing in the world as a leader for freedom.

U.S. refugee resettlement also serves as a foreign policy and diplomatic tool. The number of refugees the U.S. is willing to resettle has a direct impact on the number of refugees other host countries are willing to support, and the United Nations estimates that over one million refugees are in immediate need of resettlement around the world. Further reducing the PD would demonstrate clearly that refugee protection is no longer a priority to the U.S., and would send that message to the rest of the international community. We are extremely concerned by this, and long-term impact that setting a PD of zero will have. We urge sensible and strategic instincts to prevail.

Resettlement is a core American legacy that allows refugees to rebuild their lives. The U.S. has the capacity and ability to resettle at least 95,000 refugees next fiscal year. That number represents less than one half of one percent of the total number of displaced individuals and refugees worldwide. While the number is a fraction of those in need, this level of generosity has a huge impact around the world and in local U.S. communities. We ask that you do all you can to ensure the U.S. resettle at least 95,000 refugees in fiscal year 2020.
