Dear President Biden,

We write today as members of Refugee Council USA – a nonprofit coalition advocating for the rights of forcibly displaced people in the US and around the world – to express our deep concern with the <u>announcement</u> of a planned Notice of Proposed Rulemaking (NPRM) that would impose significant asylum restrictions reminiscent of the Trump administration. We urge you to uphold your campaign <u>promise</u> to "reassert America's commitment to asylum-seekers and refugees" and end attempts to restrict asylum for people traveling through other countries.

While we welcome the new pathways for Cubans, Haitians, Nicaraguans, and Venezuelans, these opportunities must not come at the expense of the right to seek asylum. No person wants to flee their home, but many are forced to do so for their own safety (and the safety of their families). Those seeking asylum may not always have the means or the access to use an online app, nor safe enough conditions to be able to apply from their home country.

Your administration's recent expansions of the use of Title 42, and the pairing of the creation of a safe pathway for some with the denial of access to asylum for refugees seeking protection at the U.S. border, is a troubling precedent. Any rule that seeks to ban, disrupt, limit, or delay people from seeking asylum not only undermines both US and international refugee law but also goes against who we are as a nation and our core values. Actions taken by the United States to limit access to asylum reverberate loudly around the world. The UN High Commissioner for Human Rights, Volker Türk, stated that these policies "risk undermining the basic foundations of international human rights and refugee law," while UNHCR stressed that it is "not in line with refugee law standards." Other governments will take note of this disregard for the UN Refugee Convention and respond in kind.

We strongly urge you to abandon the planned NPRM, to oppose any further asylum restrictions, and to uphold your promise of building a welcoming immigration system that

truly reflects who we are as a nation, including by prioritizing humanitarian protection for forcibly displaced persons.
